

***At Lazarex Cancer Foundation, we reimburse patient out-of-pocket travel expenses so you can travel to clinical trial appointments, helping you get where you need to be when you need to be there to take advantage of tomorrows cancer breakthroughs today.***

**Are you worried about out-of-pocket expenses making it difficult for you to participate in the sEAPort Expanded Access Program?** Lazarex Cancer Foundation can offer help through the PATH Program (Patient Access Transforming Health). You may qualify to have out-of-pocket travel expenses reimbursed for participation in the sEAPort Early Access Program through the Lazarex PATH Program.

**What is the Lazarex PATH Program?** We understand the financial difficulties that cancer patients face. Cancer is an expensive disease to treat and it can often take a toll on your financial health as well as your physical health. For 14 years Lazarex Cancer Foundation has been helping patients stay enrolled in cancer clinical trials by reimbursing the out-of-pocket expenses associated with participation. Lazarex has partnered with Oncopeptides to offer the PATH Program to patients for out-of-pocket expense reimbursement incurred while enrolled in the sEAPort Expanded Access Program.

**How do I apply?** The process is simple and secure.

1. Let Lazarex, your CRC or Social Worker know that you are interested. You may call Lazarex at 877-866-9523 or go to our website at [www.lazarex.org](http://www.lazarex.org)
2. The PATH Patient Financial Reimbursement Application is available from your CRC or Social Worker or on-line at [Download Application](#)

If you need assistance or have questions Lazarex is here to help, just give us a call.

4. You will need to submit proof of income (Pay stub, Social Security, tax return, etc.)
5. Lazarex will reply within 3 business days to let you know if you qualify.

**Who qualifies for financial reimbursement?** The PATH Program reimburses all patients who qualify on a sliding scale up to 7x Federal Poverty Guidelines. For assistance with finding out if you qualify, please call Lazarex at 877-866-9523 or ask your Social Worker or Clinical Research Coordinator (CRC). Eligible applicants must meet specific annual income guidelines and provide proof of income such as the first two pages of the last years signed copy of their income tax return, a copy of their most recent paycheck, unemployment check, Social Security, SSI, SSD, or public assistance benefit notification. The annual income cannot exceed levels outlined below:

**What expenses are eligible for reimbursement?** Travel costs eligible for reimbursement are lodging, gas, tolls, parking, taxi, Uber, Lyft, bus, etc. The whole point is to make sure that you can get to your treatment without having to worry about how you are going to get there!

**What can I expect if my request is approved?**

1. You will sign an agreement with Lazarex Cancer Foundation that outlines your anticipated expenses, the amount that Lazarex has approved for reimbursement, what is required from you and when and when you can expect to receive payment.
2. Reimbursements are provided monthly based upon submission of travel log and receipts.

**Is my info safe?** All processes are safe and secure... all shared data is de-identified.

**How long can I expect to be reimbursed?**

As long as you are a participant in the sEAPort Early Access Program.

**What happens if I go off of my trial?** Inform Lazarex that you are no longer participating in the sEAPort Early Access Program. Reimbursement will end upon processing the last travel log you submit.
